MADELEY PARISH COUNCIL MINUTES OF PARISH COUNCIL MEETING held on Thursday 5th August 2021 at The Madeley Centre, New Road commencing at 7:00pm.

Prior to the commencement of the meeting a short update was given on the progress of HS2 project by Community Engagement Manager Phase 2a, Rebecca Lewis. The scheme received Royal Assent this year. Bore hole trial pits had commenced. Early environmental works would commence autumn 2021. The main works would not commence until 2024. The next round of face to face events would take place in the winter. The community fund was open for applications and she would encourage groups to look at the Groundwork's site for further information. The update was received and questions were asked. The meeting was temporarily suspended by the Chairman as a result of shouting and disruption from two Parishioners in the meeting. Order could not be immediately restored resulting in the presence of two police officers. The police officers then left and the meeting recommenced. Ms Lewis was thanked for her attendance and she left the meeting.

There were four members of the public present. Two of the Parishioners wished to make comments about HS2 presence and also the leasing of Manor Road Playing Fields to Madeley White Star. The two Parishioners then left the meeting.

157.08/21 To consider approving and signing the Minutes of the last Regular Meeting held virtually on Thursday 24th June 2021

RESOLVED subject the amendment that the matter of complaints about parking and behaviour of some anglers around Madeley Pool had been raised at the last meeting by Cllr Hopkin and needed to be noted in the minutes; they be signed as a true and accurate record by the Chairman.

158.08/21 To consider any matters arising from above

There were no matters arising.

159.08/21 To receive Reports from Borough and County Councillors.

a. County-

- PN expressed concern that there were a number of outstanding highways jobs that had been closed that he may not be aware of. There were 252 jobs outstanding ranging from Bower End Lane, drains, guttering and brickwork. New Road had been categorised as "low priority". He encouraged everyone to contact their MP to secure more funding for Road repairs and to constantly report issues to show the urgency of the problems. £22billion was needed to carry out all of the repairs across the County. PN to check on the criteria used to assess repair priority.
- Trying to obtain funding from the EA to fund flooding improvements in Station Road.
- Meeting with some residents from Bar Hill re speeding and collisions with a view to finding solutions.
- Covid Recovery fund is still open for local communities to cover non capital spending.
 Each County Councillor has £2500 to spend-guidance for applicants are on the web site.

b. Borough-

- The weir at Madeley Pool has been cleared by specialized contractors funded by NBC
- Quotations to install a 10ft measuring gauge had commenced.
- Still chasing Bar Hill and Bower End flooding issues
- Contacted Western Power over a series of cuts and dips in power-Western Power trying to locate the source of the issue.
- Waste bin on lamp post outside Merlin Green to be chased by GW with Street scene.

- a. Grant scheme. The current balance of £2700 was noted. There was an application for funding from Lea Court Residents Association for the purchase of outdoor furniture and a water butt. It was **RESOLVED** to grant the sum of £325 for this project.
