Notice of surveys on the junction of A51 Nantwich Road to A525 Newcastle Road and Manor Road

High Speed Two (HS2) is the new high speed railway for Britain. Working on behalf of HS2 Ltd, Kier is carrying out surveys and investigating ground conditions along the Phase 2a route.

What we are doing

We will be carrying out ground penetrating surveys to help us identify the location of buried utility services, such as gas, electric or water. These surveys are non-intrusive, we will use a machine that transmits an electromagnetic pulse into the ground. These pulses reflect off features in the ground, allowing us to collect data and to understand the depth of the buried utility services.

Along with ground penetrating surveys, we will carry out several other surveys. For the safety of both our workforce and motorists, we will put temporary traffic lights on the A51 Nantwich Road to A525 Newcastle Road and a road closure on Manor Road in Madeley.

When the work will take place

The ground penetrating survey and topographical work will take place from **Monday 10 January to Friday 4 February** to return **Monday 21 February to Friday 25 February**. Please note that all our planned roadworks may be subject to change due to weather conditions or unforeseen circumstances.

Covid-19

We are working in line with Government and Public Health England (PHE) advice on working safely during the pandemic. For all events and engagement, we will carry out a risk assessment and put in place control measures to manage the risk of Covid-19 to the public and our staff. How this will affect your journey

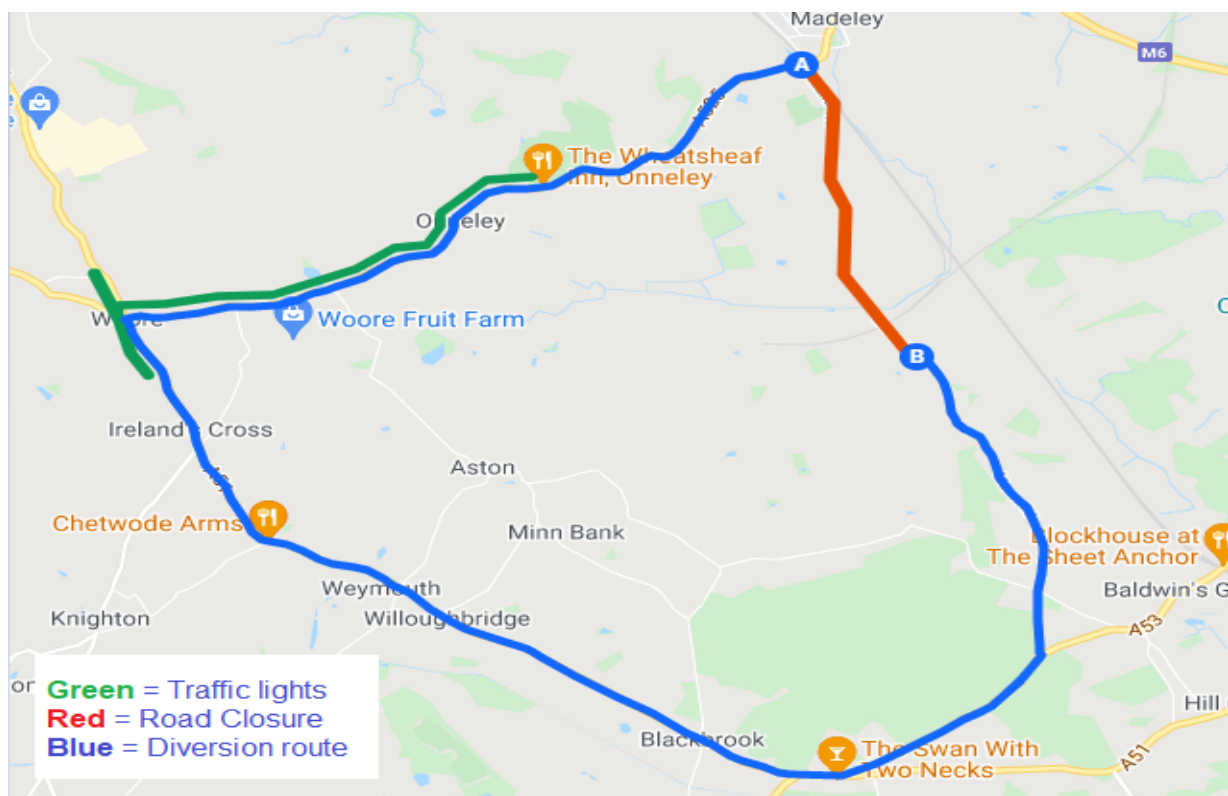
On **Monday 10 January** to **Friday 4 February** (excluding weekends) from 9am to 5pm we need to install temporary 3-way and 4-way traffic lights. These will be located on the A51 Nantwich Road and A525 Newcastle Road, and will differ each day as we move along the carriageway. During these times, journeys may take longer than usual.

On **Monday 21 February** to **Friday 25 February** from 9am to 5pm we need to close a small section of Manor Road. We will put signed diversion route in place for motorists to the A525, A51 and the A53. Please allow an extra 25mins for your journey.

How we will minimise disruption

To minimise disruption, we will be undertaking the work using temporary traffic lights where possible. The nature of the work is non-intrusive and should not affect nearby properties. We will maintain access to all properties within the traffic management set up.

About our Community and Business Funds

Two funds are now open for applications from local communities and businesses affected by the construction of HS2. They are the Community and Environment Fund (CEF) and the Business and Local Economy Fund (BLEF). £5 million has been allocated to the funds for phase 2a of the railway.

The CEF is designed to give communities the opportunity to share in the benefits of HS2. It is an allocated fund that communities are able to apply for, to help to support local projects that aim to improve their local area.

The BLEF is designed to support local economies that may be disrupted by the construction of HS2. BLEF grants are for local business support organisations and local authorities to help maintain business activity in local communities.
